

The Company ..... undertakes to respect, within the scope of the operations entrusted to it by Total Liban SAL, all the following clauses listed under the title “Fundamental Principles in Purchasing”.

## **Fundamental Principles in Purchasing**

Suppliers shall comply – and ensure the compliance of their own suppliers and subcontractors – with the laws in force, policy guidelines of the Code of Conduct of Total (of which an excerpt is attached hereto), or equivalent principles thereof, as well as the Principles for Purchasing defined hereinunder:

### **1. Preventing corruption, conflict of interests, and fighting against fraud:**

- Fight against fraud;
- Prevent and ban any form of corruption: active or passive, private or public, direct or indirect;
- Avoid conflicts of interest, in particular when personal interests may influence professional interests.

### **2. Respecting the competition law:**

Comply with the applicable competition law

### **3. Fundamental labor rights:**

To ensure that work conditions do not contravene the principle of dignity or other fundamental rights of the individual, as defined and protected by the United Nations Universal Declaration of Human Rights (UDHR) and by the fundamental principles of the International Labour Organization (ILO).<sup>1</sup>

### **4. Protecting health, safety, and security:**

- Perform risk analysis and assessments in these areas and implement appropriate means to prevent those risks;
- Establish a system for monitoring events that occurred in these areas.

<sup>1</sup> Particularly, to respect the rules relating to: prohibiting forced labor and child labor; security at work; establishing a work contract; working time, rest, and parental leave; handling discriminations and harassment in the workplace, freedom of expression, freedom of assembly and collective bargaining; freedom of thought, of conscience, and of religion.

<sup>2</sup> The purpose of such a system is to:

- Identify and manage the impact of industrial activities, products, or services
- Constantly improve environmental performance

Implement a systematic process to define environmental objectives, to reach them, and to demonstrate that they have been fulfilled.

#### **5. Preserving the environment:**

- Implement an appropriate environment risk management system, in order to identify and control the environmental impact of activities, products or services, to continuously improve environmental performance, and to implement a systematic approach to define environmental objectives, achieve them and demonstrate that they have been achieved;
- Undertake the improvements needed for protecting the environment;
- Limit the impact of industrial activities on the environment.

#### **6. Promoting economic and social development:**

Create a climate of trust with stakeholders, engaging in a dialogue with local communities, promoting local sustainable development initiatives.

Compliance with the above-mentioned laws and principles may be audited.

#### **7. Subcontractor management policy:**

- To systematically notify the subsidiary and formally declare all employed subcontractors, their fields, and action levels.
- To keep a list of names of participants and subcontractors.
- To hold security meetings for subcontractors' workers, in order to comply with the rules, "Work Permit", and "Prevention Plan" of TOTAL Liban.
- To formally delegate responsibilities to their subcontractors, namely the security rules required by TOTAL Liban.
- To ensure that personal protective equipment and collective protective equipment of subcontractors are adequate with respect to the risks of the work on the sites.
- To ensure that subcontractors' employees are aware of TOTAL Liban's site emergency plan, and namely be aware of their responsibilities in the event of an emergency.
- To ensure that subcontractors' employees who undertake specific tasks hold a certified license (example: welding license, electrician certificate, adequate driver's license).
- To assess subcontractors in respect to compliance with the company's policy and HSE rules.

Total's relation with respect to its suppliers and service providers is governed by the following principles:

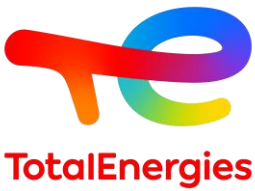
- to ensure that the interests of all parties are taken into consideration, in clarity and fair contractual terms;
